Announcement of Analytical Sciences and National Doping Test Institute Mahidol University

on No Gift Policy

Fiscal Year B.E. 2568 (2025)

As Analytical Sciences and National Doping Test Institute Mahidol University is determined to become World Class University, with the emphasis on pursuing the university's mission to have good, effective, and sustainable management system. This follows the principles of Good Governance and the Sustainable Development Goals (SDGs), as well as is in accordance with the National Reform Plan for Corruption Prevention and Suppression on No Gift Policy of the Office of Public Sector Anti-Corruption Commission (PACC) for the Fiscal Year B.E. 2569

By the virtue of section 34 (1) of the Mahidol University Act B.E.2550 (2007), the President of Mahidol University has issued the following policy:

Clause 1 Analytical Sciences and National Doping Test Institute Mahidol University declares itself as **“an organization in which every government officials do not accept gifts of any kinds during /before/after performing their duty”** This is to prevent any forms of corruption.

Clause 2 The Analytical Sciences and National Doping Test Institute Mahidol University has issued No Gift Policy to be followed by the government officials working for the university as follows:

2.1 Do not accept gifts nor benefits of any kinds from performing ones' duty.

2.2 Do not offer gifts or benefits of any kinds to outside people contacting the university.

2.3 Do not accept or offer gifts nor benefits of any kinds from/to persons, organizations, working units, or companies that used to be, are being, or might be partners or contracting parties of the university, relating to any forms of procurement.

2.4 Do not pursue or perform any acts with the goals to obtain gifts or other benefits that are illegal.

2.5 As for accepting or offering gifts as a part of traditions and conventionality or to show good manner, it should be considered according to appropriateness. The value of the gifts or benefits, however, shall not exceed 3,000 baht or beyond the legal limits. Be careful not to undervalue the gifts and benefits to be lower than their actual ones.

2.6 It is advisable to use greeting cards or social networking instead of gifts to express congratulations, good wishes, welcoming, or condolences in various occasions following conventionality.

Clause 3 Heads of working units have the responsibility to emphasize and communicate the policy issued in this announcement to their personnel in a concrete manner, with the aim for the personnel to follow the policy strictly.

Clause 4 The vice president supervising Good Governance of the university shall issue the guideline for this policy to be in accordance with the guideline of the Office of Public Sector Anti- corruption Commission (PACC).
